Insolvency & Restructuring Q&A -Spain

Spain along with Greece and Portugal has been under a lot of scrutiny over the state of their finances. There has been an on-going debate to the 'European bail-out' and whether certain countries could withstand another year like 2010.

Lawyer Monthly speaks to top legal expert, José Pajares, to find out how he thinks the Spanish economy will fare, and if 2011 will hold any surprises to boost the Spanish economy and image...



Has insolvency and restructuring increased since the global recession? What sort of effect has it had on locally based businesses?

Insolvency, and in a lower percentage the restructuration (as Spanish Insolvency law doesn't make this operative easier, despite the modification approved by the RDL 3/2009 of May 27th 2009, and waiting for the law which reformed the Insolvency Law and whose draft has been approved by the Spanish Government on December 17th, 2010) has greatly increased in the last two-three years; only in 2010 we can see a decrease around 3% in connection to 2009.

Obviously this situation has lead to the closing down of many companies and the loss of many jobs, but above all the chain effect between suppliers and clients.



What would you advise companies who are unable to reconcile their debts, are there any preventive steps they can put into place?

From my personal point of view the only viability is to negotiate out of Court upon close rules with all the Creditors so that the company can continue with its activity acquiring goods and with its commercialisation making these suppliers stronger, and in time and, of course with a deduction, to pay the previous ones.



What sort of approach has the government taken vis-à-vis companies that are unable to pay their debts?

An attempt has been done in Spain with the RDL 3/2009, on 27th of March, but it was insufficient and

for this reason the Spanish Government on December 17th, 2010 has approved the draft of the law which modifies the Insolvency Law.



What are the typical errors committed by companies involved in restructuring?

There is no doubt that the overhang and the investment in unnecessary assets always.





What if any legislative progressions do you see for insolvency and restructuring?

A compulsory mechanism for all the creditors it must be created in order to permit the company to go on if it could keep itself with positive cash-flow, independently on the payment of the previous debt. This with its future development it will create wealth to deal with them. Moreover, it was necessary (see GM case) to allow that it would be approved by 1/3 of the creditors. **LM** JANUARY 2011
